

Product Warranty

Stainless Doors, Inc. warrants its doors and frames under normal use and service for a period of one (1) year, and that the door and frame will maintain its structural integrity as intended by the design for which it is sold for the specified use of the building for which it is originally installed, in accordance with the following:

This warranty shall be null and void if Stainless Doors, Inc.'s products are subject to improper storage, shipping & handling, vandalism, willful damage, improper maintenance, unreasonable abuse, accident, misapplication, or installation not in accordance with HMMA-840-99 "Guide Specifications for Installation and Storage of Hollow Metal Doors and Frames" and/or Stainless Doors, Inc. specifications and instructions.

This warranty only applies to Stainless Doors, Inc.'s doors and frames furnished as the manufacturer's product and does not extend to cover finish painting, hardware, glass or other components, performed by other agencies (manufacturers, suppliers, distributors). Modifications made by Stainless Doors, Inc. are valid under this warranty.

It is the owner's responsibility to ensure the following:

- That Stainless Doors, Inc.'s products are handled, stored, and installed in accordance with HMMA-840-99 "Guide Specifications for Installation and Storage of Hollow Metal Doors and Frames" and/or Stainless Doors, Inc. specifications and instructions and any other instructions appearing on our web site (www.stainlessdoors.com), on the door label, or in packing (shipping) materials.
- That proper maintenance, lubrication and replacement of malfunctioning hardware is performed on a regular basis so as to maintain the structural integrity of Stainless Doors, Inc. doors and frames.
- That notice in writing will be given to Stainless Doors, Inc. of any alleged failure or deterioration of the product immediately upon the discovery thereof, or within a reasonable time after which it should have been apparent.

If the owner does not satisfy the terms and conditions stated herein, then Stainless Doors, Inc. will have no liability under this warranty agreement.
